Our Community Grants program invites local grass-roots organisations to apply for up to \$5,000 to support local communities where we work and live, aligned with our values.

Who can apply?

Local community groups, charitable or not-for-profit organisations in Western Australia delivering initiatives for communities in the Pilbara and Gascoyne regions and beyond.

How much can I apply for?

Organisations can apply for \$5,000 per calendar year.

What we can support

Leichhardt will support initiatives that provide benefit to the community local to the Leichhardt operations and align with our values framework.

The key areas include community health and wellbeing; community liveability; education and training; culture and diversity; and environment and biodiversity.

Activities we may support include:

- Sporting clubs to buy equipment and uniforms for regular use.
- Training and upskilling for umpires, coaches, and other sports officials.
- Hosting community events to strengthen local connections.
- Expanding resources to improve community program delivery.
- An awards night to celebrate local heroes.
- Hosting mental health workshops open to all community members.
- Running youth engagement programs during school holidays.
- Upgrading equipment like technology and furniture for smoother community organisation operations.
- Supplying equipment for outdoor community projects, such as laptops and shade structures.
- Providing books, crafts, and cooking supplies for children's programs outside school hours.
- Running programs that support the elderly and vulnerable.
- Offering training for non-profits in areas like social media, finance, and marketing.

What we can't support

- Requests from individuals, for-profit companies, or government agencies.
- Political, religious, or sectarian organisations.
- Core government services like education or health programs.
- Organisations outside our local community or already in partnership with Leichhardt.
- Events or initiatives that have already taken place.
- Groups that have not fulfilled previous Leichhardt funding requirements.
- Operational expenses like rent, utilities or wages.
- Travel costs, unless incidental and with significant benefit to the local community.
- Merchandise, consumables, or fundraising efforts such as charity events or raffles.
- Individual clubs under a larger association or league.
- Events with entry fees that limit participation.
- Fees for individual registrations or uniforms (for one-season only).
- Replacing items previously funded by Leichhardt.
- Purchase or supply of alcohol.
